(13) Pursuant to the "List of diseases, in the presence of which a person cannot adopt a child, take him under guardianship or patronage", "Disorders of gender identity" refer to diseases that do not allow adopting a child, guardianship or patronage This circumstance will not allow, for example, a transgender parent raising a child to seek legal registration of a change of gender, since the price of his, her or their gender recognition may be separation from the child.
